**2. EDUCATIONAL QUALIFICATION:**

The minimum qualifications required for the following posts,

Name of the Posts	Minimum qualifications
<b>Office Subordinates</b>	1. Must have passed VII class(7 <sup>th</sup> ) examination 2. Must be able to ride the bicycle 3. Must be able to read & write in Telugu
<b>Watchmen/ Night watchman</b>	1. Must have passed V class (5 <sup>th</sup> ) or its equivalent examination 2. Must be an Ex-serviceman or must have been trained in Civil Defense or as a Home guard. 3. Must be able to ride a Bicycle 4. Must be able to read & write in Telugu

- 3) Age: The applicant should have completed (18) years of age as on 01.01.2021 and should not have completed (47) years of age as on the said date and other provisions will be applicable as per Govt. Norms

- 4) Selection of candidates will be made on the basis of percentage of marks obtained in the qualifying academic examinations i.e., as indicated against the

posts as above, besides taking into consideration of preferences applicable if any.

NOTE: The candidates who did not study 7<sup>th</sup>/5<sup>th</sup> are not eligible to apply since percentage of marks in 7<sup>th</sup>/5<sup>th</sup> is the criteria for selection for the respective posts.

5) The rule of reservation will be applicable as per Govt. norms as per Roster register of respective departments.

**IMPORTANT INSTRUCTIONS:**

1. Applying candidates can download the detailed notification, the format of application and the details of vacancies from the District Website "**srikakulam.ap.gov.in**"
2. The applications should be accompanied with the following documents duly attested with Gazetted officer.
  - a) Educational qualification documents
  - b) 7<sup>th</sup> class/5<sup>th</sup> class marks sheets
  - c) Study certificates up to 7<sup>th</sup> class/5<sup>th</sup> class
  - d) Caste certificate issued by the Tahsildar
  - e) Date of birth certificate
3. The candidates should compulsorily fill the application with full details and send the applications along with above documents through Registered post or courier only with the address "**THE DEPUTY DIRECTOR, SOCIAL WELFARE, DRDA Complex, SRIKAKULAM**".
4. Separate applications shall be filed for each post and one application for 2 or more posts will be summarily rejected.
5. Application, in which any portion of the required information is not correctly and completely given, will be summarily rejected.

7. The above posts will be considered as local posts and to be filled up with 100% local candidates.
8. If two or more candidates acquired same marks for one (1) post, then eldest of the candidates as per Date of Birth, will be considered.
9. Applicant will be disqualified who attempt to canvas or to bring influence to bear on the District Selection Committee personally or by a letter. The same penalty will be imposed if any relative, friend, patron, official or other persons attempts to influence the Collector on behalf of the applicant.
